

# **Certificate of Appreciation Nomination Guidance and Criteria**

The ILDS, as part of its work in global dermatology, aims to recognise dermatologists and others in the field of dermatological care who have made an outstanding contribution to improving the outlook for people with skin diseases. The League has a specific ILDS Awards Committee that considers recommendations for individuals which might receive one of our Awards.

One of these Awards is the ILDS Certificate of Appreciation. These Certificates are awarded annually to a number of individuals and are presented to the awardees at various national and international meetings.

This is an opportunity for your Society to nominate individuals from your own Society whom you consider might be suitable for an ILDS Certificate of Appreciation. You can nominate up to two persons, whom you think might be eligible.

The Certificates of Appreciation aims to recognise dermatologists and others in the field of dermatological care who have made an outstanding contribution in one of the following categories:

### 1. International Leadership

These are dermatologists that have shown international leadership which has made an impact on global health policies and practices, furthering of cross-border research, education and empowerment of dermatologists, their societies and the public.

#### 2. Humanitarian Dermatology

Those that have been undertaking their work in a selfless, humanitarian and not-for-profit manner to improve the skin health of people in under-served areas of the world.

#### **Awards criteria**

Candidates will be considered by the Committee with reference to the following criteria which should be illustrated in the candidate's CV and nomination form.

### **Category 1: International Leadership**

This may include reference to the following and should focus on the impact and outcomes of the involvement:

- Number of years practicing dermatology.
- Honorary Membership of International Societies.
- International-level mentorship, education and/or empowerment initiatives.
- International Leadership at Society Board Member level.
- Involvement in International Dermatology Programmes, Initiatives and Congresses.
- Articles published in international peer-reviewed journals or books published that have contributed to furthering international/humanitarian dermatology.
- Demonstrable impact of the contribution of this individual to furthering international leadership in dermatology.

### **Category 2: Humanitarian Dermatology**

How has the individual contributed to improving dermatological care of patients in under-served areas of the world?

- Number of years practicing dermatology.
- Demonstrable impact of the contribution of this individual to improving dermatological care of patients in under-served areas of the world.
- Articles published in international peer-reviewed journals or books published that have contributed to furthering humanitarian dermatology.

Members of the ILDS Board, past and present, are not eligible to be nominated for this Award. <u>Here is a list of past Awardees</u>. Certificates may only be awarded once.

You will not be able to save your progress on the nomination form. Therefore, before you start to complete the form please ensure that you have the necessary information to answer the following questions:

## **International Leadership:**

- 1. How has your nominee contributed to furthering international leadership in dermatology which has made an impact on global health policies and practices, furthering of cross-border research, education and empowerment of dermatologists, their societies and the public? (300 words max.)
  - Honorary Membership of International Societies
  - International-level mentorship, education and/or empowerment initiatives
  - International Leadership at Society Board Member level
  - Involvement in International Dermatology Programmes, Initiatives and Congresses
  - Articles published in international peer-reviewed journals or books published that have contributed to furthering international dermatology
- 2. Please specify the impact of the contribution of your nominee to furthering international leadership in dermatology. (300 words max.)

## **Humanitarian Dermatology:**

- 1. How has your nominee contributed to improving dermatological care of patients in under-served areas of the world? (600 words max.)\*
  - Please detail the work that the nominee has carried out in under-resourced countries specifying the impact that the work has had.
  - Where possible include details of number of people that have benefited from the activity and in what way.
  - Please detail any articles published in peer-reviewed journals or books published that have contributed to furthering humanitarian dermatology.

You will also need to upload the CV for your nominee.
